# Introduction

#### Introduction

GRAD ME EDUCATION, recognizes the importance of confidentiality and the protection of personal information. This Privacy Policy applies to GRAD ME, its affiliates and all GRAD ME owned and operated websites, subdomains and other online platforms and explains how we use and protect the Personal Information we hold, and how you can control the collection, correction and/or deletion of Personal Information.

## **Personal Information We Collect**

For the purposes of this policy, "Personal Information" means information about an identifiable individual or information that permits an individual to be identified and which is collected by GRAD ME through the use of our services, including our website and any other online platforms that may be offered or operated from time to time. Personal Information does not include business contact information, such as name, title, business address and business telephone number when used for business communications.

Depending on the nature of your interactions or relationship with GRAD ME, we may collect such Personal Information as your first and last name, postal and email addresses, telephone number(s), social network data, information concerning your social circumstances, including age, date of birth, marital status, employment details and job title, education/qualification information, gender, religion, race, health details and other sensitive Personal Information. For the purposes of certain services we offer, with your consent, we may also collect Personal Information pertaining to your dependents, who may be minors. We may also collect certain technical information about your use of our website and online platforms, including your IP address, the type of browser you use, access times, pages viewed and the referring link through which you accessed our website or platform. If you choose to engage in the purchase of any service from us, we or our third-party payment processors will collect your payment information.

Technologies such as cookies, beacons, tags and scripts, which are identifying technologies that your computer receives when you visit certain websites are used by GRAD ME . In certain circumstances, we may match or correlate this information with personal information that you may have previously submitted to GRAD ME to improve our service offerings to you. Most browsers can be set to reject all cookies but features of our website may not work as intended if that option is chosen. We use permanent cookies to analyze website usage. We also use Google

Analytics, Google Tag Manager, Google AdWords (Conversion Tracking), LinkedIn (Conversion Tracking), GPT CHAT, Optimize, Unbounce, Hotjar, Intercom and HubSpot. Some or all of these tools may be used to track information about your behaviour on our website depending on your region.

# **Our commitment**

GRAD ME takes responsibility for maintaining and protecting Personal Information under our control. We review this policy and our personal data protection practices regularly to ensure that we are in compliance with applicable legislation and current best practices.

## How we collect personal information

We only collect personal information as required to meet the purposes that we have identified. We do not indiscriminately collect or retain personal information.

GRAD ME typically collects personal information that is voluntarily provided by the individual in question. At times, however, personal information is obtained from other sources, such as government bodies or third parties such as employers, references and service providers, as permitted by law. If required by applicable law, we will seek your explicit consent to process your Personal Information collected by GRAD ME and/or volunteered by you. The granting of such consent is entirely voluntarily; however, if you do not grant the requested consent, your use of the services provided by GRAD ME, including our website and any other online platform that we may offer from time to time may not be possible.

## How we use information

Depending on how you interact with us and the Service, we use your personal information to:

- Provide, activate and manage your access to and use of the Service;
- Process and fulfill a request, order, download, subscription or other transaction;
- Provide technical, product and other support and to help keep the Service

working, safe and secure;

- Enhance and improve the Service and our other products, events, and services and to develop new products, services and benefits;

GRAD ME may also collect and process any Personal Information that you volunteer in our website forms, including when you sign up to receive newsletters or other information from GRAD ME.

#### **Your Choices**

We may share your personal information with our affiliates and with sponsors, joint venture entities and other third parties, including entities for which we are acting as an agent, licensee, application host or publisher, that wish to send you information about their products and services that may be of interest to you, as determined by your choices in managing your communications preferences and other settings.

The Service may let you post and share personal information, comments, materials and other content. Any such contributions that you disclose publicly may be collected and used by others. Please be careful when disclosing personal information in these public areas.

# **For Legal Reasons**

We also will disclose your personal information if we have a good faith belief that such disclosure is necessary to:

- meet any applicable law, regulation, legal process or other legal obligation;
- detect, investigate and help prevent security, fraud or technical issues; and/or
- protect the rights, property or safety of LexisNexis, our users, employees or

others; and

• as part of a corporate transaction, such as a transfer of assets to or an acquisition

by or merger with another company.

# **Grounds for processing**

When we collect or otherwise process any personal information within the scope of applicable data protection laws, we do so:

- where necessary to provide the Service, fulfill a transaction or otherwise perform a contract with you or at your request prior to entering into a contract;
- where necessary for our compliance with applicable law or other legal obligation;
- where necessary for the performance of a task carried out in the public interest;
- where necessary to enable our customers to comply with their legal obligations;
- where applicable, with your consent; and/or
- where necessary to operate our business, protect the security of our systems,

customers and users, detect or prevent fraud, or fulfill our other legitimate interests as described in sections 2-4 above, except where our interests are overridden by your privacy rights.

Where we rely on your consent to process personal information, you have the right to withdraw your consent at any time, and where we rely on legitimate interests, you may have the right to object to our processing.

#### **Data retention**

We retain your personal information for as long as necessary to provide the Service and fulfill the transactions you have requested, or for other essential purposes such as complying with our legal obligations, maintaining business and financial records, resolving disputes, maintaining security, detecting and preventing fraud and abuse, and enforcing our agreements.
